

Hi Beanstalks!

If you want to print out the Bean Pod* to look like a book:

1. Print out the pages (you might check the “reverse order” box when you print so the end product is a pile of spreads in the right order, with the cover on top, and the Calendar page right under it. Otherwise you’ll have to put the pages in order yourself.

2. Then take the cover page, place it face down on the table and put the stack (with the Calendar page being on top) on top of the faced-down cover page.

3. Staple in the corner, and fold in half like a booklet, and you’ll have the closest thing you can get to a booklet without using a saddle stitcher!

*If you want to save your color ink, you can print it in black and white.

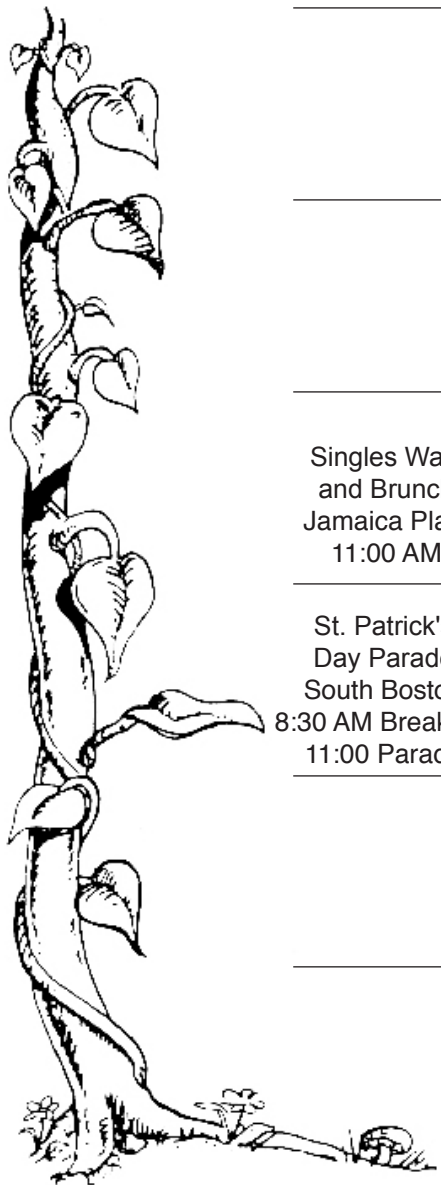

Albert V. "Big Al" Wainwright Jr. 73, a longtime resident of Westford died on Friday, February 29, 2008. He was born on October 7, 1934, in Chelmsford, the son of the late Albert V. Sr. and Jean (Bergsten) Wainwright. He was a United States Army Veteran who served in the 23rd Infantry at Fort Benning, Georgia. He graduated from Chelmsford High School, Class of 1952. He then furthered his education at Northeastern University and the Boston Museum of Fine Arts Institute. He was an avid skier, who invented and patented the SKI-RYT ski-sharpening tool. He was also a member and former president of the Lawrencian Ski Club of Bartlett, NH, a member of the Mountain Meisters, and raced NASCAR well into his 60's. He had skied the North Conway area since the 1950's as well as Idaho, Colorado Rockies and Tuckerman's Ravine. He was the past president of the Boston Beanstalks Tall Club and was elected Mr. Tall Boston, 1998. He completed two Boston Marathons, boxed in the Golden Gloves heavyweight division and was a competitive long distance swimmer. During the early 60's he played semi-pro football for the Billerica Knights, Nashua Giants and Quincy Patriots. He also trained with the 1961 Boston Patriots of the American Football League. He enjoyed traveling to Las Vegas and Mohegan Sun as well as playing the lottery. He is survived by a sister; Nancy W. Coleman of Westford, two nephews; Bruce A. Coleman and his wife Carol and David W. Coleman all of Westford. Mr. Wainwright also leaves two great nieces; Kristin J. Coleman and Stacy K. Coleman, both of Westford. **Visiting hours will be held on Tuesday from 2 to 4 p.m. and from 6 to 8 p.m. at the Blake Funeral Home, 24 Worthen St., CHELMSFORD.** Funeral Services will be held privately. PROPOSED BYLAW CHANGE

To Be Voted on at the March, 2008 Business Meeting

The purpose of these changes is to streamline the annual membership renewal process by renewing all members at the same time each year.

Article 4 Dues and Fees Section 1: Dues

Previous wording:

- A. Single Members shall pay dues annually, payable on the anniversary of their acceptance into membership in the Club.
- B. Married Members shall pay dues annually, payable on the anniversary of their acceptance into membership in the Club.

Proposed wording:

- A. Single Members shall pay dues annually, payable on July 1st of each year. Payment for initial membership will be prorated to the amount due for the number of months between acceptance into membership in the club and the regular July 1st annual renewal for all club members.
- B. Married Members shall pay dues annually, payable on July 1st of each year. Payment for initial membership will be prorated to the amount due for the number of months between acceptance into membership in the club and the regular July 1st annual renewal for all club members.

Meeting called to order at 7:00 PM

Present: Marie Austin, Elaine Senay, Kay Helberg, Jan Huffman, Susan Huffman, John Bewick, Kathy Lewis, Craig Scherman, Stephan Shcherby, Jeff Stevens

OFFICERS' REPORTS:

PRESIDENT: Joan out of the country.

VICE PRESIDENT: Marie discussed in detail the results of the "Tall Ball" Anniversary Dance. A very enjoyable time for those who attended (54 attendees). The band was excellent and very well received. We were very pleased with the hotel in regards to location, service and venue. They didn't lock us into the 50 minimum for dinner, but took the count of 34 a few days before the event and we still got the room for free (instead of \$500 if we had not had dinner). The food was very good but we will need to decide next year if it is fiscally worth it to have dinner since there were limited club members in attendance and the (generous) price breaks did not seem to attract more folks for dinner. It was noted that dinner was helpful in attracting the out of town tall club members who attended. The hot appetizers were appreciated by attendees (they were complimentary as a result of last year's fire alarm issue). There was a lot of marketing that was done for the event, it was agreed that we need to market the event throughout the year. We got a couple of attendees from the Boston.com website and only got 2 people from the listing in the Boston Event Guide (which didn't seem worth the expense). Brunch the next day had a good turnout but was not an appropriate venue. Next year we will either have it at a member's home or at the hotel (to accommodate out-of-towners).

Marie will be exploring venues for a dance in April.

SECRETARY: The January Secretary's report, published in the Bean Pod, was accepted as written.

TREASURER: Robyn not present submitted report. Treasurer's report accepted with one modification: \$105 of raffle proceeds to be moved from the dance account to the scholarship account thereby increasing the amount of subsidy from the General Fund.

MEMBERSHIP: Due to increased work demands, Kristen Gallagher has tendered her resignation Membership Director (after having just taken over

the role). We discussed options – one member has expressed an interest. Will need to clarify with Kristen how we will transfer the duties.

We reviewed the schedule developed to implement annual renewal for membership dues. This change will require a bylaw change. Marie wrote up the proposed bylaw change to be published in the March Bean Pod in order to be implemented in the new fiscal year (effective July 1st). Craig will continue to send out renewal notices by mail for now.

We also discussed criteria for membership and our role as a Board in the process.

SOCIAL DIRECTOR: Jane not present.

PUBLICITY: Wini not present sent a report. We continue to have the 1st & 3rd Fridays listed on Craig's List.

We are set for the St. Patrick's Day Parade in South Boston. We have a list of members who have committed to riding or walking in the parade and encourage others to participate in this fun event! To assist with parking and to add to the event we will be meeting in Quincy for breakfast and taking the T into town together, followed by dinner at our usual stop, Fowlers.

EDITOR: Linda not present sent report.

February was our first electronic Bean Pod. Members excited about the color photos, although there was a question about how large they are when inserted (as they took a good amount of time for some folks to download). There was some confusion re: the best way to print/staple. Linda requested clarification of the King & Queen listings in the Bean Pod – we will readdress at our next meeting.

HISTORIAN: Craig is in possession of Oliver Gruter's book on the history of TCI. If anyone wants to borrow it they can sign it out from Craig. Still awaiting the missing archives from Paul Morgan. Craig will contact Paul to see if we need to develop a plan to gain access and collect all of the information again.

DATABASE: Need to insure that we have updated email addresses of our members as we switch to the electronic newsletter. Other than missing the January renewals, we have not received any word of missed members. John Bewick asked Craig for a list of members without email addresses and offered to follow-up with those few members to strategize delivery. Craig received clarification on database reports.

WEBMASTER: Jan reports the site has been updated. Stefan Shcherby volunteered to head the Web Sub Committee and has been working on a new look for the website and presented the Board with various designs he has created. We were excited and impressed with the options – still need to work on what it will take to implement.

SCHOLARSHIP: The link is up on the website and Kathy is directing any applicants to apply via hubtall.org. The deadline for applications is March 1st. \$105 proceeds from the 50/50 raffle at the Anniversary dance will be added to the scholarship fund.

NEATO DELEGATE: Kay reported that there were no changes this month in the upcoming NEATO events.

MARFAN LIAISON: Paul not present

TCI DELEGATE: Arthur not present.

NEW BUSINESS:

WEEKEND:

We need to have a location for our fall weekend in order to make a decision by March. John reported that he has been looking at options at ski resorts in New Hampshire where we could use condos and there would be a good spot for afterhours. Also discussed the need to be open minded about other afterhours options. Acknowledged the need to keep changing up the weekend location to make it enticing to BBTC members in addition to other Tall Clubs.

Here are the official job descriptions for elected positions:

President

Duties include:

1. Calling and presiding over Executive Board (hereafter referred to as "Board") Meetings.
2. Calling and presiding over Membership Meetings.
3. Appointing all committees, subject to Board approval.
4. Serving as ex-officio member on all committees.
5. Having one year's experience as a Board member before assuming the position of President.
6. Making sure that duties of other offices are fulfilled.

Vice-President

Duties include:

1. Being responsible for making all arrangements pertaining to the dances, including payment of all expenses.
2. Temporary or permanent take-over of presidential duties when the president is not able to fulfill those responsibilities.
3. Responsibility for fund-raising activities.

Secretary

Duties include:

1. Taking minutes at each Board and Membership Meeting.
2. Typing up minutes in detailed format and sending a copy to each Board member.
3. Typing up a summary of Board minutes to submit to the Newsletter Editor for inclusion in the monthly newsletter.
4. Providing copies of minutes to interested members at the next Board and/or Membership Meeting.
5. Maintaining copies of minutes in an appropriate file that will be made available at each Board Meeting.
6. Maintaining a current resolutions list to be updated on a monthly basis.
7. Maintaining an updated BBTC Bylaws document.
8. The Policies and Resolutions document shall be maintained by the Secretary as a handbook reference, reflecting only current policy (as determined by acts of the Board and/or Membership). Policies which have been repealed or superseded should be deleted. Similar or overlapping policies should be combined to minimize verbosity and confusion.

Treasurer

Duties include:

1. Maintaining all Club bank accounts in a Board-approved bank.
2. Writing checks for all routine operating expenses without prior Board approval.
3. Writing checks for non-routine expenses with Board approval.
4. Planning a yearly budget based on past spending documentation.
5. Receiving and distributing all moneys pertaining to club business.
6. Maintaining a regular and accurate account of all Club receipts and disbursements (not just the checkbook) and submitting a monthly report to the Board.
7. Submitting periodic summary reports for various club events (e.g. dances, weekends, etc.) to the Board.
8. On request from the Board, presenting books and accounts for audit at the end of the fiscal year by a qualified individual or firm that will be appointed by the Board.
9. Providing the incoming Treasurer with appropriate documents and signature cards for a smooth turnover of checking account privileges.
10. Submitting proper documentation to the IRS to maintain a tax-free status.
11. Filing the annual corporate report with the Secretary of the Commonwealth of Massachusetts by the due date.
12. Submitting periodic treasurer's reports for publication in The Bean Pod.

TCI Delegate

1. The delegate should be a Member of BBTC for one year, be a Member in good standing, someone who knows the changes that will be presented, be able to attend the annual TCI Delegates Meeting, and be able attend the June BBTC Members' meeting. Responsibilities of the delegate include a written report for presentation to the Board, and subsequent publication in the newsletter upon return in a timely fashion.
2. The delegate will provide the editor with the minutes of the TCI Executive Board.

All Board Members

Duties include:

1. Attendance at all Board Meetings.
2. Attendance at all Members Meetings.
3. Familiarity with and adherence to all of the BBTC Bylaws and the Policies & Resolutions.
4. Submission of monthly reports on activities to the Board.
5. Promotion of the Club to members and non-members alike.
6. Maintenance of current membership status while on the board.
7. Itemization of reimbursable bills to be given to the Treasurer in a timely fashion.
8. Preparation of a proposed annual budget for their particular job.
9. Turning over all permanent records to the Club Historian and all supplies and samples to the incoming Board member at the end of the term of office.
